#### The Clerk's Association visits the General Assembly and is working hard for you!

Thursday, February 17, 2022 Clerk's of court from around the state gathered at the General Assembly to meet with Senators and Delegates to bring attention to a most pressing matter in the District Courts, staff compensation.

The association is urgently asking for an amendment that each District Court employee receive \$2500 as a salary increase which would require approximately \$4 million be added to the budget. This would be in addition to the 5% salary increase for all state employees that is in the Governor's budget for each year of the budget. While we do not think that this will solve all of our salary and retention issues, we believe it is a reasonable request in light of the current budget forecast and request for an additional 120 positions already in the budget. Although we understand that asking is not always getting, we are hopeful and doing our absolute best to fight for our staff statewide. Association members and leader-

ship went to Richmond to meet with Delegates and Senators for a face -to-face discussion about our most urgent needs. Our goal was to humanize our stories so when it comes time to make a decision, it really resonates with them. Thank you to everyone who took the time to respond and provide your stories. The Judge's Association has written a resolution to show their support as well. I can't recall a more impressive show of support and solidarity on compensation.

There is still a lot that has to happen before the raise is approved, but we are one step closer.

The legislators will vote on their respective budget at the end of the week and then it goes to conference for them to reconcile the two versions. After conference. it goes back to the floors for a vote and then once approved to the Governor for his amendments.

Cyril's charisma, kind and approachable personality make statistics, otherwise overwhelming and humdrum data, easy to understand and dare I say actually kind of fun (at times).

My first class with Dr. Miller. At the time I was one of the very few members from Virginia to attend a MAACM conference held in a casino in Delaware. Cyril was the instructor of a statistics class scheduled first thing in the morning (after a night at a casino, that is a tough crowd to captivate-with statistics no less). Let me tell you, that audience came to bright eyed and bushy tailed attention when everyone took notice of the large stack of calculators on his desk. Equivalent to saying "remember this it will be on the test later!"

Throughout the class he was energetic, clearly loved to teach and explained each concept in ways that could be easily understood no matter your familiarity with the topic. I remember him stating that we were all successful planners because we all made it to the conference and his class. Before that moment, I really hadn't thought of myself as a good planner and the steps that we all subconsciously take to accomplish a goal (as simple as getting to work.)

#### **Biography**

Cyril W. Miller, Jr. holds a Master's Degree in Urban and Regional Planning and a Ph.D. in Public Administration with a focus on judicial administration. Prior to 1980, Dr. Miller taught in Richmond Public Schools and worked in various urban and regional planning areas. He spent two years abroad in France and Quebec, Canada, between 1980 and 1982. He has served in various capacities within the Office of the Executive Secretary of the Supreme Court of Virginia since 1982

and in the department of Judicial Planning continuously since 1989. Before becoming a permanent member of the Judicial Planning Department, Dr. Miller worked in Fiscal Services as a budget analyst/programmer with duties ranging from accounts receivable to automation of fiscal work flows. He served as a Senior Management Information Analyst in the Planning Department responsible for providing statistical and policy analyses on caseloads and workloads for all Virginia courts and directing the development of the annual State of the Judiciary Report and the Report of the Judicial Council of Virginia. In that capacity, Dr. Miller worked daily with judges and court officials as well as personnel within the Office of the Executive Secretary on various routine and special projects, was responsible for directing the statistical components of system-wide policy analysis efforts, such as appellate courts' time-to-disposition studies, the weighted caseload staffing model for Virginia's district courts, as well as the

various calendar management and delay reduction programs for Virginia's circuit and district courts. In 2005, Dr. Miller became Director of the Department of Judicial Planning, which department is also responsible for the strategic planning efforts of the Virginia court system. In addition, he has taught university level courses in future studies, criminal justice planning, as well as statistics and research methods.

# Change your mindset NOW to that of <u>SURVIVAL</u>.

The presentation was held on December 1<sup>st</sup> at 9:30 am and was open to everyone in the Patrick County Veterans' Memorial Building. We had 16 participants in total and the attendees were from JDR court, GD court, Social Services, DMV, County Administration, and Building Inspection.

The class took approximately one hour and 15 minutes. The training was well received with interest from multiple offices within the building. The Sheriff and Major were very informative.

Most important lesson to be learned: CHANGE YOUR MINDSET

#### NOW TO ONE OF SURVIVAL.

Columbine changed everything. It was the first televised active shooter event.

ADD Concept (same as Run, Hide, Fight)

Avoid (Run) Deny (Hide) Defend (Fight)

#### **Characteristics of an Active Shooter**

- $\Rightarrow~$  Coward. Can't handle life. Basically want to chicken out at the expense of others.
- $\Rightarrow~$  Looking for soft, defenseless targets
- $\Rightarrow$  Ax to grind
- $\Rightarrow$  Series of life events have turned against them
- $\Rightarrow\,$  Evil/Mean. We are too quick to blame it on mental illness most of the time.
- $\Rightarrow$  They often have no real profile
- $\Rightarrow\,$  Avenger mentality. Revenge to get at whoever for whatever reasons.

## **Active Shooter Presentation** *Continued*

#### 3 Types of people, Lt. Colonel David Grossman.

**Sheep:** Vast majority of the population. Want to be led. Cannot defend themselves.

Wolf: Evil incarnated. Preys on the sheep.

Sheep Dogs: Protect sheep. Commonly thought of as law enforcement, military. I NEED ALL OF YOU TO BE-COME SHEEP DOGS, STARTING TODAY.

#### During a traumatic event, we go through three mental phases: Denial, Deliberation, and Decisive moment.

- ⇒ Denial example: "Those aren't gunshots, or are they?"
- $\Rightarrow$  Deliberation: "What am I going to do now?"
- ⇒ Decisive moment: "I need to act, now." Revert to ADD (Run, Hide, Fight) concept.

## AVOID

Get out at any cost. Think outside the box. This is your best option for survival in an active shooter event. Break windows; everything is an option.

## DENY

- $\Rightarrow$  Lock doors. This buys you time.
- $\Rightarrow$  Cut off lights. Gives the impression that the room is empty.
- $\Rightarrow$  Barricade: Doors opening into the room

(toward you), move heavy furniture against the door

⇒ Barricade: Doors opening away, tie the handle to an anchor point in the room to prevent it from being opened. If you do not have a rope, use a belt, power cord, or anything else you can find.

## DEFEND

Fight dirty. Be relentless. You are going to live. Period. Use everything you have as a weapon.

- $\Rightarrow$  55 percent of all active shooter events end before law enforcement response.
- ⇒ 37 percent of the time, the attacker either kills themselves or leaves the scene prior to LE response.
- $\Rightarrow$  18 percent of the time, the victims stop the attack by subduing the attacker.
- $\Rightarrow$  45 percent of all active shooter events end when LE arrives.
- $\Rightarrow$  15 percent kill themselves or surrender to LE.
- $\Rightarrow$  30 percent are killed or stopped by LE.
- $\Rightarrow$  96 percent of active shooters are male.
- $\Rightarrow$  They come from all racial and ethnic groups.
- $\Rightarrow$  A handgun is used by the suspect in nearly 60 percent of active shooter events.
- $\Rightarrow$  LE officers are shot 24 percent of the time when they enter an ongoing active shooter event.

#### LE Response

- ⇒ Once on the scene, we have one initial mission: TO FIND THE SHOOTER(S) AND TERMINATE THE THREAT. WILL GO DIRECTLY TOWARD THE GUNFIRE.
- $\Rightarrow$  We may have to bypass victims in order to find the threat.
- $\Rightarrow$  Keep hands visible when LE arrives.

- Be authentic. Leadership, no matter what your position, is more important now than ever before. Acknowledge that it is okay to not be okay. Ask your colleagues and employees how they are doing and how you can best support them.
- Get to know your Employee Assistance Program (EAP), Lawyer Assistance Program (LAP), and other well-being resources already available so you can communicate effectively about available resources and connect others with them.


