career, Debra stated, "I think when I was hired at Circuit Court, they did so because of my neat handwriting in all those huge books that were part of the court's records. When I first became Clerk of Norfolk J&DR District Court, we had only typewriters and dummy terminals in the office. One of my first challenges was to obtain computers for everyone, and as time went on, I volunteered for every pilot project that OES would throw at me. My team always met any hurdles and accepted my belief that we should drive the bus rather than be run over by it. My passion for the judicial system is as strong now as it was in 1973 when I began at the Norfolk Circuit Court.

Over the years I have forged so many wonderful relationships with other Clerks across the state and learned from all of them. That is one of the main reasons I joined the Executive Council of the Association of the District Court Clerks of Virginia. I have benefitted from everyone's experiences and knowledge. It has been such a collegial and collaborative journey as we addressed the needs for more staff and higher salaries. I am honored to be a small part in moving the profession forward and improving the working conditions for our employees. We are not where I hoped we would be as I plan my retirement, but with the leadership of the Council we will be there one day.


