#### In early March there was news to celebrate: 90 FTE had been approved for FY21, and 30 additional FTE had been approved for FY22. District courts would see 120 new FTE total over the next two fiscal years. Raises for all state employees were on the horizon. It seemed to be great news to beleaguered and

Then, Friday, March 13, 2020, arrived, and all of a sudden the coronavirus was a real threat in the U.S. Many courts gathered that weekend with community leaders to discuss what to do. On March 16, 2020, the Chief Justice issued the first Order Declaring a Judicial Emergency. Many courts closed for a few days to figure out how to operate under the provisions of the Order.

suffering court employees. Help was on the

way.

The economy took an immediate and sudden downturn once the Governor issued Executive Order 55, effectively closing restaurants and other businesses under a "stay at home" Order. Suddenly, the hope for new positions and raises for employees was eviscerated. While the positions remain unfunded in the budget beginning July 1, 2020, they are in a category of new funding slated to be "delayed" rather than stricken entirely; however, in this "new world" we are living in, there are too many uncertainties to plan any celebrations just yet.

The timing of all of this is a real tragedy, especially since district courts were already woefully understaffed and will be working under remarkable and unprecedented conditions when the Judicial Emergency ends. As Kristi Wright, director of legislative and public relations for the Supreme Court's Office of the Executive Secretary, said in a statement, "we hope that when it is time to restore the funding, the essential nature of the services provided by these positions will be recognized and prioritized" (*Richmond Times-Dispatch*, April 29, 2020).

As of this writing, the Judicial Emergency Order has been extended thrice since entry of the original Order, and is presently set to expire June 7, 2020.

## Special Issues Committee Report: Pay Banding and Court Composition Issues

The Clerk's Association Special Issues Committee convened a meeting in Virginia Beach on February 13, 2020. Clerks around the state met to discuss many issues impacting all district courts, but the primary reason for meeting was to focus on eliminating current grades in order to move to a pay band classification system, as well as to standardize court composition based on size.

A summary report was issued to the Executive Secretary on March 9, 2020. An excerpt from the document is included to the right: One common theme evolved in both the workgroup and in other discussions with various Clerks throughout the state: every district court regardless of size, type, geographic location or staffing level has at least one component unique to their court which creates a stressor and limits their success.

Small courts struggle with the coordination of so few staff that the absence of one employee is profoundly felt. Many small courts have difficulty finding employees with Alexandria GDC: Congratulations to Hope R. Mayfield, for her exemplary service with the Alexandria General District Court, from July 1, 1979, until her retirement on March 31, 2020. the abilities and skills we require to be successful on the job. These employees must be able to retain a vast amount of knowledge, without the constant repetition found in larger courts. This is particularly emphasized in Combined courts and compounded throughout the state since over 100 courts fall into the small court category.

Equally significant, Virginia's 30 large and extra-large courts have difficulty finding employees with the ability and skillsets to accomplish single-scoped and redundant case processing, while serving an immense customer base. Coupled with the stressors of volume and the inherent intensities of managing large caseloads, numerous court requirements, and multiple personnel issues, large courts often have additional stressors levied upon them by their localities due to the large local budgets and physical plants they are managing.

Medium sized courts are not isolated from any of these issues, instead, they generally face the dilemmas identified in both small and large courts, on a larger or smaller scale.

In sum, Virginia's district courts still have a lot to learn about each other and the various issues all sizes of courts face; however, one thing remains the same: the level of service delivery, access to justice, and due process afforded every Virginian must be the same in every court, regardless of size or location.

Due to COVID-19, there has been no further discussion regarding the workgroup's findings. While disappointing, we understand that we are operating in unprecedented times, and have received acknowledgment from the Executive Secretary that once things return to "normal," we will be able to turn our attention to this important issue in due time.

of you, we had court the very next morning. We had 283 cases on that next docket. How do you prepare for that? You can't (very well). The next morning, we had our sheriff's office out front directing traffic and separating people throughout all the waiting rooms and letting people come to our office to sign for the new date (one at a time). We got through it but what an experience! Our next court date was a little smaller and thankfully we had a little more time to contact all parties to reschedule. By the 3rd or 4th docket that we had to continue hundreds of cases for, we felt like pros! We, like many of you, have spent the last few weeks contacting plaintiffs and defendants of new dates, calling multiple attorneys, defendants, the commonwealth attorneys, sending out notices, sending and answering a million emails, etc... I believe the most interesting and frustrating part of this experience while we have been doing all of this "behind the scene" kind of work is how many times we have been asked if we are bored! It has amazed me just how many people don't have a clue what we do or what it takes to make the court run smoothly. Things have been better in the last week or two here in Westmoreland. We seem to be finding our groove but I do worry about what court will look like when the state is opened back up. This month, it is hard to imagine... So far, we are healthy here and pray for that to continue. Be safe and hopefully this will all be behind us soon.

During the COVID-19 Declaration of Judicial Emergency we have used our time wisely.

#### From Ginger L. Webb, Clerk of Court, Buena Vista Combined District Court




