## **Annual Address by Karl Hade**

Since the Association could not hold an annual conference again in 2021, Mr. Hade agreed to make his annual address in our publication this year:

Dear District Court Clerks,

I am sorry we are once again unable to meet in person. The past 15 months have been extremely challenging as we have all worked hard to keep our courts open during a major pandemic. Our ability to remain open was made possible by your dedication, ingenuity and commitment to providing essential services to the citizens of Virginia. I know these have been difficult and stressful times and I am grateful and proud of your efforts. Hopefully, the worse of the pandemic is behind us and we will soon be able to return to regular operation.

Fortunately, this past year was not all bad news. So, let me provide you with some of our recent highlights. First, in the area of compensation, effective June 10, 2021, eligible employees will receive a 5% increase that will be reflected in your July 1, 2021 paycheck. We recently implemented an education rewards program providing bonus payments to those who complete the ICM Certified Court Executive Program and a salary increase for the completion of the National Center for State Courts Fellows Program.

As you know, we have been working with the Governor and leadership in the General Assembly for several years to seek funding to address our staffing shortages in the district courts. Going into the 2020 General Assembly Session, our courts were understaffed by 276 positions. Many of our courts were operating below 80% of their appropriate staffing level. In 2020, we were pleased to find strong support from the Senate Finance & Appropriation Committee and House Appropriations Committee for our staffing request. The budget they passed included \$7,596,300 for approximately 120 new deputy clerk positions. Unfortunately, our success was short-lived when these funds were soon frozen in 2020 due to the pandemic. Thankfully, the budget passed by the 2021 General Assembly Session restored full funding for Fiscal Year 2021/2022.

My staff and I worked with the leadership of your Clerks Association to propose how to allocate these positions and we have been busy contacting the courts that will receive partial or fulltime positions. These allocations will result in all courts being staffed at 80% or above. These positions will reduce our staffing needs to the lowest level since the staffing model was developed. We also hope to allocate more wage budget monies to those understaffed courts that did not receive additional positions in this process.

Although we took a significant step forward in securing proper staffing for our district courts there is still work to be done. Therefore, we plan to seek additional positions in the 2022 General Assembly Session in our continued effort to adequately staff our judiciary.

In closing, let me again express my deep appreciation for your service to the judges and citizens of the Commonwealth.

Despite staffing shortages, virtual schooling and a worldwide pandemic, you and your staff have continued to provide outstanding service under difficult and stressful circumstances. Take care and thank you for your support.

## PROPOSED BY-LAWS AMENDMENT:

Pursuant to our By-Laws, which can be found on our <u>website</u>, we are proposing an amendment to Article III (Meetings). **Concerning amendments**, our By-laws state:

#### **ARTICLE VI – AMENDMENTS**

**Section 1.** This constitution may be amended by a twothirds vote of the members present and any annual meeting.

Section 2. Any proposed amendment shall be presented to the Association membership in writing at least 30 days prior to the annual meeting at which the proposed amendment will be considered. This will allow the membership time to consider the amendment and comment thereon at the annual meeting wherein the amendment is brought to the floor for a vote.

Section 3. Any proposed amendment shall be submitted in writing to the Secretary-Treasurer and read by the Secretary-Treasurer at the opening business session of the meeting at which such proposed amendment is to be considered.

An Amendment to Article III has been proposed by the Executive Council in order to address the pandemic and our inability to meet in-person. Article III currently states:

#### **ARTICLE III – MEETINGS**

**Section 1.** Unless otherwise ordered by the Association or by the Executive Council, the annual meeting shall be held in the spring.

**Section 2.** This meeting shall be for the purpose of electing officers, receiving the reports of Officers and Committees and for any other business that may arise.

**Section 3.** The meetings shall be held at a time and place to be fixed by the Executive Council.

**Section 4.** Executive Council meetings may be held at the call of the President or by a majority vote of the Executive Council. All members of the Executive Council and any chairperson of a standing committee who are present at an Executive Council meeting shall be allowed to vote. No person shall be allowed more than one vote. Any member of the Association may attend the meetings of the Executive Council and may be heard on any matter before the council.

#### The proposed revisions are as follows (in blue italics):

#### **ARTICLE III – MEETINGS**

**Section 1.** Unless otherwise ordered by the Association or by the Executive Council, the annual meeting shall be held in the spring. During times of declared Judicial Emergency, pandemic, or other act of God, when an annual meeting cannot be held and elections cannot take place, a meeting may be held by virtual means in order to hold elections as required by these by-laws. The virtual meeting will be open to the membership at-large, but only a quorum of the Executive Council will be required for the purpose of electing officers.

**Section 2.** This meeting shall be for the purpose of electing officers, receiving the reports of Officers and Committees and for any other business that may arise.

**Section 3.** The meetings shall be held at a time and place to be fixed by the Executive Council. *During times of declared Judicial Emergency, pandemic, or other act of God, when an annual or Executive Council meeting cannot be held at a fixed place, a meeting may be held by virtual means, accordingly.* 

**Section 4.** Executive Council meetings may be held at the call of the President or by a majority vote of the Executive Council. All members of the Executive Council and any chairperson of a standing committee who are present at an Executive Council meeting shall be allowed to vote. No person shall be allowed more than one vote. Any member of the Association may attend the meetings of the Executive Council and may be heard on any matter before the council.

President's Message



# Kudos to Those Who Take Risks For Us

THERE ARE MORE THAN 2,600 judges, clerks, and magistrates who work in the judicial branch of the Commonwealth. These civil servants work in our 32 general and juvenile court districts, in the 120 courts within our 31 trial court circuits, in the Court of Appeals of Virginia, and in the Supreme Court of Virginia. Add to that number another several hundred deputies serving as courtroom bailiffs, and the number of individuals serving our judicial branch exceeds 3,000.

By the time you read this article, there will have been at least 530,000 deaths suffered due to COVID-19 in our country and approximately 29,700,000 cases of COVID reported. Yet, the individuals working in our judicial system have risen from their beds every workday for the past year and reported to their posts at great risk to their health and the health of their families. Why do they do this? They come to work to keep our courts open during this global pandemic. Their unselfish acts of simply "showing up" and doing their jobs fulfills their solemn commitment to provide access to justice for the public whom they serve. No deputy sheriff, court clerk, judge or magistrate seeks recognition for "doing their duty" or expects to be lauded as a "hero" but heroes are exactly what they are, and it is time that they be recognized as such.

I hope all of you read the January 12, 2021, "Commendation and Proclamation of the Access to Justice Commission of the Supreme Court of Virginia" published in the February 2021 edition of the *Virginia Lawyer*. For those who have not read it yet, I suggest that you do. Allow me to share part of the Commission's proclamation.

After observing that "Access to

Justice" is a fundamental and essential right in a democratic society, the Commission noted that "Access to Justice" is entirely dependent on a functioning court system. The proclamation makes the following points:

- "Whereas a functioning Court System requires the presence, dedication and professionalism of a multitude of Civil Servants, including Clerks, Deputy Clerks and other Clerks' Office Staff; Judges; Judicial Assistants; Guardians Ad Litem; Court Reporters; Foreign Language Interpreters; Magistrates, Sheriffs, Sheriffs' Deputies and other Sheriffs' Office Staff;
- "Whereas the personal interactions required of these Civil Servants to maintain a functioning Court System and provide Access to Justice during the pandemic have exposed them to greater risk of contracting the COVID-19 virus;
- "Whereas notwithstanding the increased risk they faced, these Civil Servants have made, and continue to make, substantial personal sacrifices necessary to keep the Commonwealth's Court System open and functioning, thus ensuring that Access to Justice has been maintained and preserved during the COVID-19 pandemic; ..."

The Commission's proclamation concludes by honoring these front-line court workers, and "COMMENDS these Civil Servants ... PROCLAIMS its deep gratitude for their service and ENCOURAGES all, including specifically lawyers and litigants, ... to take the opportunity to express their admiration and gratitude for the work these Civil Servants have done to maintain a functioning Court System and thereby to preserve Access to Justice for all Virginians."

I ask that the words in the Commission's proclamation be taken to heart by all members of the Bar. I invite you to put pen to paper and write a short note of gratitude to the members of the Clerks' offices where you practice and remember to say thank you to every clerk and sheriff you encounter in the courthouse each time you are in court. They are important to us all and should be recognized by us individually for their heroic service.

While I am on the subject of gratitude to those who take risks for us all, I would be remiss if I failed to give a "shout out" to the staff of the Virginia State Bar. The adage "overworked and underpaid" clearly applies to this group of public servants. Yet despite the applicability of this phrase, the staff has worked especially hard during this pandemic to ensure that the core functions of the Bar have not skipped a beat.


Finding ways to keep functioning remotely to fulfill its mission to the public and service to lawyers is far from easy. It is much easier in normal times to meet in person than it is to meet virtually given the constraints imposed upon state agencies under the law. Notwithstanding these difficulties, I can attest that the staff has guided the officers and other volunteers in our Bar family through this difficult time. Thank you all.

Last month it was my pleasure to recognize some 13 members of the VSB staff for their length of service ranging from five years to 30 years. All have made immeasurable contributions to our profession, but I wish to single out for your consideration and praise, Maureen Stengel, the Director of Bar Services, who has served us for 30 years. What Maureen accomplishes each year with an undersized staff is simply amazing. Please take the time to thank our staff for all they do for us and the risks they take, especially during this unprecedented health crisis. 52

# There is an easier way to train new and existing staff. Good news is you already have everything you need! By: Laura Hatch, Fredericksburg GDC Clerk of Court


So I will say it, onboarding new staff can be one of the most challenging duties as a clerk and supervisor. While short staffed, how do you ensure everyone is receiving the same level of detail and individual attention while being trained? What about your existing staff, are they feeling engaged and able to participate in ongoing training opportunities? How about you, are you able to keep up to date on the latest and greatest with your busy schedule? Believe it or not, you already have program installed on your а computer to help. I have been working for the state for 18 years and let me tell you, it is a game



changer.

Microsoft OneNote is a program that works well with Microsoft TEAMS or on your local "N" drive for sharing information immediately with your staff. This program easily organizes notes, weblinks, charts, files and policy/ procedures. This makes it the ideal program for an all-in-one office notebook. You can find it under the start menu or in TEAMS just click on the (+) a the top of the page on your general office channel. You can open OneNote

as a new page there or add an existing OneNote notebook. All office members that have been added to the channel will have full access to the notebook.) recording. You can actually record instruction materials and attach in the notebook as well. I think this will be an incredible time saver and a



The tabs make it easy to separate content into categories and then you can add sections and sub pages within each tab as you would in a binder. I found it easier to wrap my mind around it by grabbing one of our new hire binders and setting up the tabs to mirror the binder tabs and sections. For pages that I did not have the word document, I utilized scan max. I scanned my instructions and samples as a .pdf and added them in OneNote to the specified pages. You have the option to attach as a file or to attach as a viewable file. To save digital space, consider adding a case number for a sample, vs a scanned page so your staff can open in case management and GDIS scanning. A feature it also has but I have not utilized yet is

huge improvement on the quality of training we provide to our staff.

This new program will make it accessible to your staff, make it easy to update notes in one place and is paperless. So no more bulky binders and out dated single sheets of paper floating around at individual desks. WOW, that alone had me hooked.

Starting day 1, new staff will have instant access to all of the training materials available to them on-demand. This will free up the other staff that are treading water until the new staff is trained. Are you sold yet?

program. Just open a new page to get started!



If you can use word, you can use OneNote.



Remember this program is a tool and will only be as helpful as you make it. Make it a part of your routine to keep it up to date and training relevant and it will be an asset to your office. Wishing you a *less stressful* and *more successful* onboarding process.


